Corporate Organization

The year was 1938:

- Franklin Delano Roosevelt was President
- Hitler's troops marched into Austria
- H. G. Well's War of the Worlds was broadcast
- Benny Goodman introduced "Swing"
- 40-hour work week was established
- 40 cents an hour was the minimum hourly wage
- Xerography was introduced
- Nylon was introduced

A 25-year-old lady in San Francisco, California, by the name of Lucille Johnson Perkins, an executive secretary with National Lead Company had an idea for an organization. On April 29, 1938, Executive Secretaries, Inc. was formed as an association of key women who would work with their executives to further the interests of their businesses and for civic betterment. In 1964, ESI became international when it chartered its first Canadian chapter, Calgary, Alberta. In 1977, ESI changed its name to Executive Women International (EWI) to more accurately reflect its membership base.

The Dallas Chapter

The year was 1951:

- Harry S. Truman was President
- The Korean War was being fought
- "Cry" by Johnnie Ray and the Four Lads spent 11 weeks as #1 on the Billboard's chart
- Super Glue was introduced
- 75 cents an hour was the minimum hourly wage

Lou Ballou, Executive Secretary, Louis Egan Co., learned about EWI and took the initiative to contact other Dallas firms to organize the Dallas Chapter. On December 14, 1951, Dallas was chartered with 22 firms becoming the second chapter outside the state of California; the ninth chapter to be chartered; and the first Texas chapter to be chartered. In our 59 years of membership, Dallas has remained one of the strongest chapters in the international organization. Many of our proud moments are listed below:
